The End Is Near...

...of PC-only format accessibility in our OverDrive audio books, that is. OverDrive has upgraded our web site to handle the iPod/Mac compatible MP3 format! On December 1 our MVLC OverDrive web site started displaying MP3 titles that are now available for download. The process for finding, checking-out, and downloading an MP3 title is very similar to that of an original WMA title. Here are four points where it will look/feel a little different., however:

1. There is a new row of titles on the main page that is exclusively in the MP3 format. Mac or iPod users who want to browse titles will find the "complete list" link at the end of this row to be very useful.



2. To help distinguish between the two formats, OverDrive has built in some visual cues to show the format (WMA or MP3), platform/device compatibility (PC, Mac, or iPod), and CD burnability (yes or no).



3. Users of the MP3 format will need to make sure that they have the latest version of the OverDrive Media Console properly installed on their computer. There is a Mac version, and there is a PC version. Here are the system requirements for each version:

WMA except for the "Library Download Service Terms of Use for MP3 Titles" screen (an acceptable use policy).

This policy is meant to provide a degree of security and copyright protection for the publishers.

We do have 200 titles in the MP3 format. There are a broad variety of genres and subjects available, and we will continue to build the mp3 collection in each month's OverDrive purchase. There are more "classics" than "hot titles" available in MP3 at this time; however, as the pop title publishers become more comfortable with mp3 access to more titles in the market should evolve.

Foreign language is currently a strength in the mp3 titles. We were able to purchase 50 foreign language instruction titles in mp3. This will really help fill the void left by the departure of Rosetta Stone. There are titles for ESL English, ESL Accent reduction, Spanish, French, Italian, German, Brazilian Portuguese, Greek, Korean, Chinese, Japanese, Russian, Arabic, and Polish.

You are welcome to begin the PR process whenever is appropriate for your library. It may be effective to begin pushing the MP3's around mid-

month to have an impact over the holidays. There will soon be poster and bookmark templates as well as press release and public service announcement information available. The location of these materials will be announced on the MVLC General

Finally, one bit of education that should go along with the PR is that, given a choice between MP3 and WMA titles, a PC user should select the WMA title so that the "universal" format is available to those who really need to use it. This new beginning with MP3 titles should make many people happy over the holidays. Enjoy!

Social Security/Driver's License Numbers to be Removed From **Database**

In October, the Executive Committee approved removing all Social Security and drivers license data from patron records in order to comply with the new Standards for the Protection of Personal Information of Residents of the Commonwealth (M.G.L. Chapter 93H, 201 CMR 17.00), which goes into effect January 1, 2009. This new law establishes standards for the protection of personal data in electronic databases, requiring safeguarding wherever there's a link between an individual's name and a social security number, driver's license number, or number from any other type of government issued ID. Interestingly, public agencies (such as libraries) appear to be exempt from the provisions of the law, but private corporations - such as MVLC - are covered, and as the data is physically stored at MVLC, the consortium needs to comply. These are essentially two routes to compliance. We could either spend a good deal of money and staff time setting up and maintaining systems to protect the data, or we could simply eliminate it from the database. As only a handful of libraries collect (or have in the past collected this data), and few seem to currently use it, the easiest route, and the one chosen by

Executive, is to eliminate this data from the SS/Other ID field, Second ID field and Notes field of the patron record and then to have a policy in place to no longer collect this data as part of the patron registration process.

Before deleting the data we plan on exporting it and providing every library that wants the data, a spreadsheet containing the patron's name and the data included in those fields. This data could then be held (and/or maintained) locally.
